## **ORDER:**

In the letter second read above the Director of Public Health and Preventive Medicine has stated that the Government have sanctioned Rs.52 lakh (Rupees Fifty two lakh only) have been sanctioned vide in Government order first read above i.e. 40% of the total expenditure for the construction of the structural part of the first floor of the new building for the use of Director of Public Health and Preventive Medicine at DMS Campus, Chennai-6. In order to complete the balance construction work in the first floor of the new building, (the remaining 60% of the expenditure) and to make the entire new building into functional use a sum of Rs.78.00 lakh (Rupees Seventy eight lakh only) is necessary. Hence, he has requested the Government to sanction the balance amount of Rs.78,00,000/- (Rupees Seventy eight lakh only) so as to complete the balance work of construction of first floor of new building for the use of Director of Public Health and Preventive Medicine at DMS Campus.

2. After careful examination of the proposal of the Director of Public Health and Preventive Medicine, the Government accord sanction for release a sum of Rs.78,00,000/- (Rupees Seventy eight lakh only) to complete the construction of the balance work in the first floor of the new building for the use of Director of Public Health and Preventive Medicine at DMS Campus, Chennai.

3. The expenditure sanctioned in para 2 above shall be debited to the following head of account:

"4210 Capital outlay on Medical and Public Health -02. Rural Health Services – 103. Primary Health Centres – Schemes in the Twelfth Five Year Plan-II. State Plan – JA Buildings – 16. Major Works.

(DPC 4210 02 103 JA 1606) (Under Demand 39 02)

4. Necessary funds will be provided in the Final Modified Appropriation 2014-15. However, this expenditure shall be brought to the notice of the legislature by specific inclusion in the Supplementary Estimates 2014-15. Pending provision of such funds in the Final Modified Appropriation for 2014-15, the Director of Public Health and Preventive Medicine is authorized to draw and disburse the amount. The Director of Public Health and Preventive Medicine is directed to include this amount while sending proposal for Final Modified Appropriation 2014-15 and draft explanatory note for Supplementary Estimate 2014-15 to Government in Finance (Health-I /BG-I) Department without fail.

5. This order issues with the concurrence of the Finance Department vide its U.O. No.17/ADS(Dr.PU)/H-I/2015, dated 06.02.2015 and ASL No.2413 (Two thousand four hundred and thirteen).
