ORDER:-

The Director of Medical Education in his letter read above, has stated that the Dean, Madras Medical College, Chennai stated that the Men's hostel Sewerage line was connected with the 30 KLD Medical College Sewage Treatment Plant, since there was no sufficient load to run the same. On completion of construction of 7th & 8th floor over the existing 6th floor of the U.G Men's Hostel, the total sewerage flow will be around 80 KLD. Hence, the Public Works Department authorities have been requested to prepare rough cost estimate for the construction of 100 KLD Sewerage Treatment Plant (STP) for U.G. Men's Hostel at Madras Medical College, Old Jail Compound, Chennai. Accordingly, the Chief Engineer (Buildings), Chennai Region has prepared the Rough cost estimate with relevant details and necessary provisions, which works out to Rs.65.00 lakhs for the year 2017-2018, duly countersigned by the Director of Medical Education. Hence, the Director of Medical Education has requested the Government to issue necessary administrative and financial sanction for a sum of Rs.65.00 lakhs for the year 2017-2018 for the construction of 100 KLD Sewerage Treatment Plant (STP) for U.G. Men's Hostel at Madras Medical College, Old Jail Compound, Chennai.

2. The Government have examined the proposal of the Director of Medical Education in detail and accord administrative and financial sanction for a sum of Rs.65.00 lakhs (Rupees Sixty five lakh only) for the construction of 100 KLD Sewerage Treatment Plant (STP) for U.G. Men's Hostel at Madras Medical College, Old Jail Compound, Chennai.

3. The expenditure sanctioned in para 2 above shall be debited to the following head of account:-

“4210. Capital Outlay on Medical and Public Health –
01.Urban Health Services – 110. Hospital and Dispensaries
(including Pharmacy) – State's Expenditure – JA. Buildings –
16. Major Works” (DPC 4210-01-110-JA-1602)“.

4. The expenditure sanctioned in para 2 above shall constitute an item of "New Instrument of Service" and the approval of Legislature will be obtained in due course. Pending approval of the Legislature, the expenditure may be initially met by drawal of an advance from the Contingency Fund. The Chief Engineer (Buildings), Public Works Department is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the Contingency Fund to the Finance (BG.I) Department directly, in Form- "A" appended to the Tamil Nadu Contingency Fund Rules, 1963, along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from the Finance (BG.I) Department. The Chief Engineer (Buildings), Public Works Department is requested to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2018-2019 to the Finance (BG.I/Health-II) Department at the appropriate time without fail.
