### **ORDER:**

In the letter read above, the Mission Director, State Health Society has stated that the Government of India have transferred and credited funds into State Government Account towards its share of Grants-in-Aid for Flexible Pool for Non- Communicable Diseases during 2017-18 as detailed below:-

2. The corresponding 40% of the State Share against the 60% of the Government of India release of Rs. 9,49,00,000/- (Rupees Nine crore and forty nine lakh only) works out to Rs.6,32,66,667/- (Rupees Six crore thirty two lakh sixty six thousand six hundred and sixty seven only).

3. The Mission Director, National Health Mission, has requested the Government to sanction a sum of Rs.15,81,66,667/- (Rupees Fifteen crore eighty one lakh sixty six thousand six hundred and sixty seven only) towards the Government of India release and State share for Non-Communicable Diseases during 2017-18 as mentioned above and to authorize the Mission Director, National Health Mission and Project Director, Reproductive and Child Health Project, Tamil Nadu to draw the above amount through Treasury mode and credit into National Health Mission Account.

4. The Government after careful consideration have decided to accept the above proposal of the Mission Director, State Health Society and accordingly sanction a sum of Rs.15,81,66,667/- (Rupees Fifteen crore eighty one lakh sixty six thousand six hundred and sixty seven only ) towards the Central and State share of Grants-in-Aid for Non-Communicable Diseases during 2017-18.
