### ORDER:

In the letter read above, The Mission Director, State Health Society has stated that the Government of India have transferred and credited into State Government Account its share towards Central share of Grants-in-Aid for Non-Communicable Diseases during 2018-19 as detailed below:-

2. The corresponding 40% of the State share against the 60% of the Government of India share of Rs.16,19,00,000/- (Rupees Sixteen crore and nineteen lakh only) works out of Rs.10,79,33,333/- (Rupees Ten crore seventy nine lakh thirty three thousand three hundred and thirty three only).

3. The Mission Director, State Health Society has therefore requested the Government to issue orders for the release of a sum of Rs.26,98,33,333/- (Rupees Twenty six crore ninety eight lakh thirty three thousand three hundred and thirty three only) being the State and Central Share contribution of Grants-in-Aid for Non-Communicable Diseases Programme for the year 2018 - 2019 as mentioned above and to authorize him to draw the above amount under National Health Mission through Treasury mode and credit into State Health Society Account.

4. The Mission Director, State Health Society has also requested the Government to reappropriate a sum of Rs.2.08 Crore from the Head of Account 2211 00 103 UA 09 32 (General) to Head of Account 2211 00 794 UA 09 39 (TSP).

5. The Government after careful consideration has decided to accept the above proposal of the Mission Director, State Health Society and accordingly (i) sanction a sum of Rs.26,98,33,333/- (Rupees Twenty six crore ninety eight lakh thirty three thousand three hundred and thirty three only) being the State and Central Share contribution of Grants-in-Aid for Non-Communicable Diseases Programme for the year 2018 – 2019. (ii) A sum of Rs.30,00,000/- (Rupees Thirty lakh only) be re-appropriated from the Head of Account 2211 00 103 UA 09 32 (General) to Head of Account 2211 00 794 UA 09 39 (TSP).
