### **ORDER:**

In Government Order third read above, permission was accorded to the Director, Dr. G. Viswanathan (Raman) Institute of Engineering and Medical Science, Trichy to start Diploma in Nursing course with an annual intake of 20 seats from the academic year 1992-1993.



2. In Government Order fourth read above, permission was accorded to the G. Viswanathan Institute of Medical Sciences (Raman) to start B.Sc (Nursing) course in Dr. G. Sakunthala College of Nursing, Trichy with an annual intake of 50 students from the academic year 1998-1999.

3. The Secretary, Dr. G. Viswanathan Institute of Medical Sciences (Society), Murungapettai, Mutharasanallur Post, Srirangam Taluk, Trichy District has requested the Government to change the site of Dr. G. Viswanathan Institute of Medical Sciences – School of Nursing and Dr. G. Sakunthala College of Nursing from #41, Kiledar Street, Trichy to Keela Street, Murungapaettai, Mutharasanallur (Post), Srirangam Taluk, Trichy District.

4. In Government letter eighth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering their request. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed nursing college has fulfilled the conditions prescribed by the Government in the Government Orders first and second read above and fifth to seventh read above and the norms of Indian Nursing Council, New Delhi.

5. In his letter ninth read above, the Director of Medical Education has submitted the proposal wherein he has stated that the inspection team has conducted an inspection at the premises and submitted their report by stating that the said institution has fulfilled all the norms prescribed by the Government as well as by the Indian Nursing Council, New Delhi. Hence, the Director of Medical Education has recommended to give permission to the Secretary, Dr. G. Viswanathan Institute of Medical Sciences (Society), Murungapettai, Mutharasanallur Post, Srirangam Taluk, Trichy District for change the site of Dr. G. Viswanathan Institute of Medical Sciences – School of Nursing and Dr. G. Sakunthala College of Nursing from #41, Kiledar Street, Trichy to Keela Street, Murungapaettai, Mutharasanallur (Post), Srirangam Taluk, Trichy District.

6. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and grant permission to the Secretary, Dr. G. Viswanathan Institute of Medical Sciences (Society), Murungapettai, Mutharasanallur Post, Srirangam Taluk, Trichy District to change the site of Dr. G. Viswanathan Institute of Medical Sciences – School of Nursing and Dr. G. Sakunthala College of Nursing from #41, Kiledar Street, Trichy – 620 002 to Keela Street, Murungapettai, Mutharasanallur (Post), Srirangam Taluk, Trichy District - 620 101 from the academic year 2020-2021 before admitting the students, subject to the following conditions:-

- a) Admission of students shall be made as per the rules fixed by the Government from time to time.
- b) Tuition fees including special fees should be collected from the students at the same rates as prescribed by the Government from time to time. The Management should also give separate



undertaking stating that No CAPITATION FEE or any other fund in the name of building fund, etc. will be collected from the students seeking admission in the Private Self Financing Nursing Colleges.

- c) The Government have the right to utilize the Government Endowment fund created by the Trust in meeting the justifiable payment to students that may arise due to non compliance of rules and regulations of the Government by the Trust like winding of course without valid reasons etc.
- d) The Institute so permitted to conduct the course will be allowed to shift / change the study centres only after completion of three years from the date of actual commencement of the course by the first batch of students, after getting orders of Government on inspection of the centres.
- e) The institution should obtain building plan approval from the DTCP in the new site.
- f) The institution should obtain affiliation from the Tamil Nadu Dr. M.G.R Medical University, Chennai and if needed, suitability from Indian Nursing Council, New Delhi, respectively.

6. The Director of Medical Education is directed to take necessary further action accordingly.
