ORDER:

The Mission Director, National Health Mission has stated that the Government of India have released a sum of Rs.199,00,00,000/- as Grants-in-Aid with 100% centrally funded (no state share) towards India COVID-19 Emergency Response and Health System Preparedness Package for the Financial Year 2020-21 as 2nd tranche and credited into State Government Account for drawal through treasury as detailed below:-

The Mission Director, National Health Mission has further stated that, the Government of India, Ministry of Health and Family Welfare, New Delhi has communicated the key activities that have to be implemented for India COVID-19 Emergency Response and Health System Preparedness Package as detailed below:-

- i. Support to Districts for developments of dedicated COVID Hospitals and other Hospitals, isolation blocks, negative pressure isolation room, ICU's with Ventilators, Oxygen supply in hospitals, strengthening of laboratories in hospitals, hiring of additional human resources and incentives to human resource and community health volunteers.
- ii. Procurement of personal protection equipment (PPE), N.95 Masks and ventilators, over and above what is being procured and supplied by the Government of India.

- iii. Strengthening of identified laboratories and expansion of diagnostic capacities, including procurement of diagnostic equipment, testing kits and other reagents and mobility support for sample transport, over and above what is being procured by the Government of India.
- iv. Outreach survey and community surveillance activities including mobility supply for the same and training and orientation of health workers and volunteers, information, education and communication and awareness creation activities.
- v. Disinfection of hospitals, Government Offices, Public Utilities and Ambulance etc

3. Further, the Mission Director, National Health Mission has stated that, the following expenditures are proposed from the above sanction amount of Rs.199.00 crore under India COVID-19 Emergency Response and Health System Preparedness Package for the Financial Year 2020-21 as below-
