National Health Mission – Up-gradation of 23 Urban Primary Health Centers into 23 Urban Community Health Centers under National Urban Health Mission - Orders – Issued.

ORDER:

In Government Order first read above, among others, the Government have accorded sanction for the establishment of 280 Urban Primary Health Centres including the 243 existing facilities under the control of Urban Local Bodies and Director of Public Health and Preventive Medicine and 37 New Urban Primary Health Centres under National Urban Health Mission.

2. Now, the Mission Director, National Health Mission in his letter second read above, has stated that, the health care services to the slum/vulnerable population in Urban areas have to be strengthened as per National Urban Health Mission norms by upgrading Urban Primary Health Centres into Urban Community Health Centres. He has also stated that, Upgradation of the Urban Primary Health Centres into Urban Community Health Centres are quite essential to provide specialist services to the High Risk Mothers, LSCS, Family Welfare programmes and to reduce the patient load in Secondary /Tertiary care Hospitals. Further the MMR and IMR will reduce with adequate Human Resources to these Urban Community Health Centres (30 bedded) and the Urban Community Health Centres shall act as First Referral Units (FRUs) which may cover a population of 2.50 lakhs and shall definitely help in reducing the case load during pandemic situations in Secondary and Tertiary Institutions. Based on the guidelines of the Government of India, a detailed proposal for up-gradation of 23 existing Urban Primary Health Centres into Urban Community Health Centre in the Municipal Corporations (based on 2011 census) had been included in PIP's and approved in the RoP 2016-17, RoP 2020-21 and RoP 2021-22 as detailed below:-

Out of the above 23 Urban Primary Health Centres the Government have issued orders only for the upgradation of Urban Primary Health Centres - Kamala Nehru at Dindigul Corporation into Urban Community Health Centre at a total cost of Rs.140 lakh vide G.O.(Ms)No.544, Health and Family Welfare department, dated: 10.12.2020. He has also stated that, approval was obtained for carrying out the civil works in 17 Urban Community Health Centres sanctioned for the year 2016-17 and funds were released to concerned Urban Local Bodies and the construction work has already been completed. He has also stated that, the above proposal was

approved in 30th and 41st Executive Committee of the National Health Mission, Tamil Nadu.

3. The Mission Director, National Health Mission has therefore requested the Government to issue necessary orders in this regard.

4. The Government have examined the proposal of the Mission Director, National Health Mission in detail and accordingly do and hereby issue orders on the following:-

- i. The Mission Director, National Health Mission is permitted to upgrade 22 Urban Primary Health Centres into Urban Community Health Centres from 6 bedded Hospital to 30 bedded Hospitals as detailed below:-
